- 3. lot numbers according to municipal tax maps and names of abutting land-owners;
- 4. perimeter survey of the parcel made and certified by a Professional Land Surveyor relating to reference points, showing true north point, graphic scale, corners of parcel and date of survey and total acreage;
- 5. existing and proposed locations and dimensions of any utility lines, sewer lines, water lines, easements, drainage ways and public or private right-of-way;
- 6. location, ground floor area and elevations of buildings and other structures on this parcel existing and proposed; and the total area and location of parking lots, roads, paved areas or areas to be stripped or graded and not to be revegitated;
- 7. If the site is not to be served by a public sewer line, then an on-site soils investigation report by a Department of Human Services licensed site-evaluator shall be provided. The report shall contain the types of soil, location of test pits, and proposed location and design of the best practical subsurface disposal system for the site;
- 8. location and dimensions of on-site pedestrian and vehicular access ways, parking areas, loading and unloading facilities, design of ingress and egress of vehicles to and from the site on to public streets and curbs and sidewalk lines; a Driveway or Entrance Permit issued by the Maine Department of Transportation, if required;
- 9. Landscape plan showing location, type and approximate size of plantings and location and dimensions of all fencing and screening;
- 10. topography indicating contours at intervals of either 5, 10, or 20 feet in elevation as specified by the Planning Board;
- 11. location of aquifers and aquifer recharge areas, as delineated on the aquifers and aquifer recharge areas, as delineated on the aquifer and aquifer recharge map for the Town of Sabattus;
- 12. Mining activity proposals shall require a description of the scope of activities to be undertaken on the site, i.e., area and depth of proposed excavation;
- 14. Mining activity proposals shall include a reclamation plan;

- 16. The location of any 100 year floodplain.
- 17. The location, sizes and character of signs and exterior lighting.
